## What is this product?

Type This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

#### **Objectives**

The objective of the sub-fund is medium and long-term capital appreciation by investing primarily in a selection of undertakings for collective investment which, themselves, invest mainly in fixed income securities or similar fixed or floating-rate income securities, and/or money market instruments.

#### LUX-BOND HIGH INCOME invests:

- mainly in open-ended undertakings for collective investment which, themselves, invest mainly in fixed or floating-rate income securities or similar securities and/or money market instruments;

- incidentally in undertakings for collective investment listed or traded on a regulated market which, in turn, invest primarily in fixed or floatingrate income securities or similar securities and/or money market instruments and directly in bond or similar fixed or floating-rate income securities.

These undertakings for collective investment may invest globally, by region or individually in emerging market countries.

The sub-fund may, within legal limits, hold cash and money market instruments.

For the purpose of good portfolio management and/or hedging, the sub-fund may also use all the financial derivative instruments and other techniques/instruments set out in the Investment Restrictions in the prospectus, within the limits provided.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

### Intended retail investor

The sub-fund is particularly suitable for an investor with a moderate risk profile who wishes to participate in the performance of the bond markets and who seeks relative stability of his capital, while tolerating only limited volatility. Investors should be aware that investments in high yield and emerging market bonds are not excluded. The sub-fund is particularly suitable for medium and long-term investments, as capital losses may occur due to market fluctuations.

#### **Other information**

Depositary: Banque et Caisse d'Epargne de l'Etat, Luxembourg

Dividend income: This class is a distribution class meaning that income may be distributed.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.


Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one subfund do not affect the other sub-funds.

## What happens if Spuerkeess Asset Management S.A. is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque et Caisse d'Epargne de l'Etat, Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

## What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

#### **Costs over time**

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

#### We have assumed:

In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario

## How long should I hold it and can I take money out early?

### **Recommended holding period: 5 years**

Redemptions are possible on each full bank business day in Luxembourg. In exceptional circumstances, your right to request the redemption of your investment may be limited or suspended.
